Camp Kirchenwald: The Diocese of Harrisburg holds an annual one week residential summer camp for adults with intellectual and developmental disabilities at Camp Kirchenwald in Lebanon County. The program is for adults (ages 18 and older) with a primary diagnosis of mild to moderate intellectual and developmental disabilities who have no severe behavioral problems. Campers must be ambulatory and the camp is open to adults of all faiths.

The dates are August 15-20, 2021.

Activities at the camp are all adapted to the needs and abilities of adults with intellectual/developmental disabilities. The activities include: swimming canoeing hiking and nature study sports games arts and crafts fishing.

In addition, campers will participate in evening activities in a beautiful multi-acre wooded setting.

Cross Catholic Outreach: Cross Catholic Outreach's priority is to help "the poorest of the poor." Our efforts reach those suffering extreme poverty in countries throughout the Caribbean, Africa, Asia, and Latin America.

Projects include relief for earthquake, flood and tsunami victims, care and education for orphans and other vulnerable children, housing for the homeless, medicines and health care for the indigent, food for families suffering extreme malnutrition, and clean water for communities that have none, as well as micro-enterprise programs and other long-term development efforts to break the cycle of poverty. In every case, our method of outreach is the same:

Cross Catholic locates needy Catholic-based ministries serving the poor and distributes material aid through their existing programs.

In this way, we can supply meaningful help where it is needed most. In all our work we remain dedicated in our service to the Lord as good stewards of His resources in every challenge we seek to overcome.

competitions, set up appropriate procedures. I anticipate additional guidance on the free throw competitions at the DD meeting that will be conducted virtually on 11 and 12 December.

Feed the Hungry

Many individuals and families have already stocked their personal pantries in preparation for quarantine. This has resulted in reduced donations to local food banks, food pantries and soup kitchens. Councils are encouraged to reach out and support local food banks through donations of food and especially funds.

Action Steps

- 1. Contact a local food bank or food pantry to ask their immediate needs. Build on existing relationships from past programs.
- 2. Tell your pastor about the needs of local food banks and pantries. Ask for his permission to share this initiative with the entire parish through parish communication channels.
- 3. Prioritize giving cash or gift cards directly to local food banks and pantries so they can purchase items they need most.
- 4. If collecting food, make sure to take appropriate precautions and minimize contact with those driving up and dropping off.

- 5. Coordinate with the partner food bank or food pantry concerning their desired method of delivery for food or funds. Adhere to all relevant coronavirus precautions and guidelines.
- 6. Report your activities with the Leave No Neighbor Behind Survey at: www.kofc.org/neighbor
 Please Note: participating in the Food for Families program may be counted towards both categories (Family and community) and should be reported for both. To ensure your council's refund, please also submit the Food for Families Refund and Plaque Application (#10057). The Food for Families program is a Featured program and counts as two credits towards the Columbian Award. To obtain one credit for Leave No Neighbor Behind, completion of one additional service activity is required, in addition to 4. Feed the hungry.

Dear Worthy Grand Knights and Worthy Financial Secretaries:

Please be aware of the following critical changes to the Order's safe environment program, which are effective immediately.

EMAIL ADDRESSES ARE MANDATORY FOR ALL MEMBERS HOLDING SAFE ENVIRONMENT ROLES (grand knight, program, family and community directors, and all squires' counselors)

- Email addresses are mandatory for every member to retain access to, and be counted towards, a council's safe environment compliance for Fraternal Year End 2020-21
- Please check the Safe Environment Member Status Report in Officers Online and reach out to any members who don't have an email listed and assist them in adding a valid email address, unique, and personal to him, to his membership profile with the Knights of Columbus
- PLEASE NOTE: generic emails will no longer work, e.g., gkcouncil1@gmail.com will no longer work; personal emails are required as user ids to ensure that members retain credit for completing their training and background checks

GRAND KNIGHTS BARRED FROM HOLDING FOUR (4) ROLES

- Councils in which a grand knight also holds the program, community, and family director roles will NOT be considered compliant with the Knights of Columbus safe environment program
- This practice has never met the standard of having at least two fully compliant members at all events where youth or other vulnerable persons may be present
- This standard is in effect for the current 2020-21 Fraternal Year

Grand knights of councils who fall into this category must appoint AT LEAST one more member into either the program, community, or family director role immediately for their council to become compliant.

FREQUENTLY ASKED QUESTIONS

1 - A council's community director has no computer and he completed his safe environment training using the hard copy self-study guide. With the new requirement that all members holding safe environment roles must have a personal email, what happens to members in these roles who don't have

computers?

- If this member completed the training via the self-study guide, and sent in the acknowledgement form, it's recorded in the Office of Youth Protection
- We understand that some of our members don't have computers, but can still have a personal email created for them so that the training and background check records will be retained in the new system
- Perhaps a son or daughter can help?
- Use a smart phone or tablet to access the internet
- Such members can also visit the library in their town to access the internet to set up a personal email
- Maybe a brother Knight can help?
- As requirements are valid for THREE YEARS, we want to ensure that members retain their compliant status for all three years
- 2 Must a council fill all FOUR required positions (grand knight, program, family, and community director) with different council members or are two members permitted to each hold two positions? For example, would a council be compliant if a compliant grand knight also held the program director position and another fully compliant member held the community and family director positions? Some councils are small and find it difficult to find four members to fill the four positions.
- For this fraternal year 2020-21 ONLY, having two different members appointed into the four required roles of grand knight, program, family, and community director roles will be allowed but ONLY for the remainder of this fraternal year (June 30, 2021)
- If the grand knight is also going to hold a director role, it should be either the family or community director role (but not both) so that there will then be two fully trained and background checked members in each council
- It is common that a council's deputy grand knight also serves as the program director
- 3 The Order's safe environment standard is for a minimum of two fully compliant members to be at all events where minors and other vulnerable persons may be present. Do both members have to have the training and background check or is it permitted to have one with training and one with training and background check?
- At a MINIMUM, there must be at least 2 trained members, at least 1 of whom has also been background checked, present at all events where minors or other vulnerable persons may be present
- The Order's expectation is that, over time, more and more members will have served in key leadership roles that include background checks and training, and that there will be more than two fully trained and background checked members at events, programs, and activities where minors and other vulnerable persons may be present
- 4 What is a valid email address for the positions requiring safe environment training? Some members wish to have an email for K of C business and a separate one for their personal business. What are some examples of valid email addresses? Does the email address have to be the same as what the member has in his membership profile?
- The member management system only holds ONE email
- A member may create one that can then be used for all of his K of C business, but instead of gkcouncil1@gmail.com which is associated with the council ROLE of grand knight, one should be created like johnj.doe@gmail.com to ensure that the member's training and background check credentials remain with HIM personally for 3 years, and not with the grand knight ROLE
